- Political awareness

After **five** years of membership in BTVAR's Professional Honor Society, a lapel pin will be awarded to honorees. Years of membership **do not need to be consecutive**. After **ten** years of membership, a second lapel pin will be awarded.

Note: Courses or seminars that are required for licensure or REALTOR® membership should not be included on this application.

Requirements:

- No application fee required.
- Applicants shall submit their own applications.
- Awards shall be for the calendar year.
- Deadline for submission: **Friday, December 22, 2017 no exceptions.**
- Letters of recommendation must be dated in the calendar year.
- Minimum of 100 points to be eligible to receive award.
